<b>Description of Activities</b>	Twomey Family Remorial 2020 physical events had to be cancelled owing to COVID 19. We took a decision back in March 2020 to cancel our Twomey Family Remorial Physical events for safety reasons in accordance with government guidelines. We did however run our Twomey Family Remorial events virtually. We encouraged people to walk, run or cycle June 5 -12th and closed our Twomey Family Remorial with a virtual quiz on Google meets. We did not fundraise but promoted healthy outdoor activities and positive mental health. Medals had been ordered in January 2020, prior to Covid 19 outbreak. We took a decision to sell these medals at absolute cost plus postage, to prevent a loss for Twomey Family Remorial. People registered for free and had the option to purchase a medal. My Run Results were paid privately for administration and there was no cost incurred by Twomey Family Remorial.
